Laura Discussed the New county code adopted 9/2022

No changes for Auditors just wording updates. All previous County Code language is still correct unless stated in the update. The code is on line they will no longer send print copies out. CCAP still working on abolishing Auditors in PA change to all counties having a Controller and staff. Also, would like to change to a Direct Pay System

Luther brought up concerns for TERMS FOR EXECUTIVE BOARD — A discussion followed The Bi-Laws would need changed. Three Executive Board Members with a 3 year retention and new board members with a 2 term limit but not limited on how many terms. For example Can run two term consecutively then take a year off then back and be voted back on for additional 2 more terms etc.

More discussion on the matter in future and no vote at this time to change the bi laws.

Additional discussion on Tax collectors who carry a large balance in their checkbook. Different procedures to help find where the money belongs were suggested and if it is not determined whom the money belongs to, a Disbursement between all the municipalities should be recommended.

Janis stressed that tax collectors CAN Not Charge Any Fees. The Ethic Commission enforces this. If Bank charges a Fee they are permitted to charge a few but no more than the bank charge.

Barb Benkovic from the Bureau of Unclaimed Property gave a presentation going into great detail on UNCLAIMED PROPERTY and Reporting. To Educate on the process of identifying, reporting and Claiming Unclaimed Property from the department of the Treasury.

Reminded Deadline is April 15th but recommending submitting as early as possible Barb discussed Escheat checks. That you can submitted checks as unknown if no record of owner. Also noted that manual submitting will be eliminated in the future. Recommend Using the online portal.
